4. (U) COUNTERINTELLIGENCE ASSESSMENT, 2-8 DEC 88.
MIDDLE EAST THREAT. NUMBER OF VAGUE THREAT MSGS DURING PAST WK INDICATED RADICAL PALESTINIAN GPS COMING TO WESTERN EUROPE TO CARRY OUT ATKS AGAINST ISRAELI, PLO, AND US INTERESTS. IN SOME CASES IT APPEARS THAT PLO CONFIRMS THIS THREAT DATA BECAUSE OF ITS CONCERN THAT RADICAL PALESTINIAN GPS AND OTHER ELEMENTS WILL ATTEMPT TO UNTRACK PLO INITIATIVES. PLETHORA OF THREAT RPTG USUALLY ACCOMPANIES INCREASED MID EAST TENSIONS OF THIS TYPE. FRG POLICE CONTINUE TO INVESTIGATE THREAT TO "US MIL IN RASTATT" BUT CURRENT DATA SUGGEST PAGE 05 RUFDAAB2371 CONFIDENTIAL NOFORN WHINTEL THIS IS NOT VALID THREAT.

5. (U) ASSESSMENT OF TERRORIST THREAT LEVEL FOR US MIL INTERESTS 2-8 DEC 88. CRITICAL: NONE. HIGH: ATHENS, MEDIUM: FRG, ITALY, TURKEY, SPAIN AND CYPRUS. LOW: GREECE, BELGIUM, FRANCE, AND PORTUGAL. NEGLIGIBLE: UK, THE NETHERLANDS, LUXEMBOURG, AUSTRIA, SWITZERLAND, NORWAY, DENMARK. NOTE: THREAT ASSESSMENT LEVEL APPLIES TO US MIL PERSONNEL AND INSTALLATIONS IN A GIVEN COUNTRY. 1. (U) MID EAST. ACCORDING TO [REDACTED], TEAM OF PALESTINIANS NOT ASSOC WITH PALESTINIAN LIBERATION ORGANIZATION (PLO) INTENDS TO ATK US TGTS IN EUROPE. TIME FRAME IS THE PRESENT. TGTS SPECIFIED ARE PAN AM AIRLINES AND US MIL BASES.

(U) DOCSINT COMMENT. WE CANNOT REFUTE OR CONFIRM THIS THREAT INFO. WE ASSESS IT AS CIRCULAR RPTG, POSS VERSIONS OF MID PAGE 02 RUFDAAB2371 CONFIDENTIAL NOFORN WHINTEL EAST THREAT ITEMS IN 29 NOV AND 1 DEC CIDS. DOCSINT CONTINUES TO VIEW THIS THREAT RPTG AS BY-PRODUCT OF INCREASED TENSIONS BETWEEN PALESTINIANS AND ISRAELIS BECAUSE OF PALESTINIAN NATIONAL COUNCIL DECISIONS AND RESULTANT POSSIBILITY THAT RADICAL PALESTINIANS OR OTHER ELEMS WOULD ATTEMPT TO TORPEDO CHAIRMAN ARAFAT'S INITIATIVES.
